The Tax advisory Chamber of Slovenia pursuant to the second paragraph of Article 3 of the Rules on passing the exam for a tax advisor (hereinafter: the Rules)

SCHEDULES 10. EXAMINATION DEADLINE TO TAKE THE EXAM FOR A TAX ADVISOR

which will be held on Friday, January 17th 2020, starting at 13:00, in the lecture hall at the seat of the Tax Advisory Chamber of Slovenia, Parmova ulica 53, Ljubljana.

Based on article 2 of the Rules, persons who meet the following conditions may take the exam for tax advisor:

1. Must be a citizen of the European Union,
2. To have at least a college degree,
3. Have three years of practical experience in tax, auditing or accounting,
4. That he/she has completed education (lectures) on Slovenian tax legislation, lasting at least 48 hours.
5. Must be fluent in the official language of a member of the European Union,
6. That he has not been convicted of a criminal offense against property, business or legal affairs by a judgment which has the force of res judicata (including probation) and has not been sentenced to two or more years of imprisonment

The applicant must provide proof of compliance with the required conditions upon application. The following shall be considered as relevant evidence:

- Photocopy of passport or identity card (point 1 and 6 of the tender conditions),
- Original or certified diploma of higher education (minimum 15 years of work experience) or higher education (point 2 of the tender conditions),
- A certificate from the employer or employers of at least three years' practical experience in tax, auditing or accounting (point 3 of the tender conditions),
- Original or certified copy of proof that he/she has completed education (lectures) on Slovenian tax legislation, which lasts at least 48 hours (point 4 of the tender conditions)
- A certificate from the Ministry of Justice of the Republic of Slovenia (point 6 of the tender conditions)

Candidates who have completed their education at the "Ivan Simič Tax Academy" do not have to submit the evidence from item 4 of the tender conditions.

The examination, which will be held in writing and last for a maximum of five hours, in accordance with Article 10 of the Rules, covers knowledge of tax regulations of the Republic of Slovenia and practical examples in the field of tax consulting.

The application deadline is Friday, December 13th, 2019 inclusive. The application is sent to: DAVČNO SVETOVALNA ZBORNICA SLOVENIJE, Parmova ulica 53, 1000 Ljubljana, s pripisom »APPLICATION FOR EXAMINATION«.

The fee for the preparation for the exam, admission to the exam and for the examination is 700.00 EUR (without VAT), half of the fee must be paid at the time of registration and the other half before the entrance to the exam, i.e. no later than 12.01.2020. Make the payment to the TRR number: **SI56 2900 0005 2877 564**, reference **00 10-2020**.

After receiving and reviewing the applications, the Examination Board will notify all the candidates with a decision on the eligibility for admission to the examination.
