23/02 To receive declarations of disclosable pecuniary interest on any matters of business. None

23/03 To approve the minutes of the meeting held on 1st December 2022. The minutes were approved and signed as a correct record.

23/04 To note the resignation of Cllr. J Nellist from the Parish Council. LOPC expressed its gratitude for the work he had done during his time on the parish council, particularly regarding the new village sign. Noted

23/05 To approve to co-opt Julie Hawkins onto the parish council (moved to end of meeting)

23/06 Public Participation (Standing orders are suspended for this item).No members of the public present.

23/07 To receive reports from the County and District Councillors:

County Cllr. Warneken: Following marathon meetings over two days, the constitution and budget for the new unitary authority has been agreed, unfortunately with a budget deficit of £30m, mainly due to energy costs and inflation. County Cllr. Warneken is one of the 7 members on the planning committee for Selby and Ainsty. He is also on the committees for Transport, Environment and Economics and the North Yorkshire Moors and National Parks. Interesting times are ahead but he believes a good effort has been made to ensure a smooth transition.

District Cllr. Myatt: County Cllr. Paraskos is to be chair of strategic planning committee for NYC. There are proposed boundary changes before next election but unclear where Little Ouseburn will be placed.

DPD New Settlement and Caddick application – one third of the land has been removed from the application and it is unclear what will happen next. There is to be a liaison meeting between HBC and neighbouring villages on 21st March. Clerk to report back to the PC on this meeting.

23/08 Update on measures to reduce speeding on B6265 and Main Street – Wheelie bin stickers were being distributed to all households and the VAS will be installed later in the year. County Cllr. Warneken suggested requesting advisory signage on B6265 (like Moor Monkton) If approved by NYC, these would have to be self-funded. There also might be the possibility of installing "Slow Down" signage on B6265. Clerk to investigate County Cllr. Warneken would try and arrange for a highways officer to attend the next PC meeting.

23/09 To approve the design and position of the VAS and sign the installation agreement.

As only one VAS can be purchased at this time, it was approved to be placed on the verge at Newbury House.

This position is not only the optimum place according to NYCC but would also allow for a solar VAS to be purchased.

The PC can only choose a VAS approved by NYCC, which unfortunately does not include "smiley" faces and actual speeds. The pole and VAS are to be mostly funded from County Cllr. Warneken's Locality Budget 2023/24. This means the order cannot be placed before next month.

The installation agreement was signed.

23/10 To approve replacement of Cherry Tree, Main Street – Approved. The clerk has asked permission from NYCC. The PC requested that their contractor removes the unsightly stump left from the fallen tree.
