23/49 VAS Update: A 450mm battery powered VAS is on order. Many thanks to County Cllr. Warneken for £2000 donation from his Locality Budget to assist in funding. It was approved to install an additional VAS pole at the Village Hall end of Main Street without undertaking a non-compulsory speed survey. Clerk to contact NYC to agree on a suitable site and ask County Cllr. Warneken if the funding he agreed to give for the survey could be put towards the cost of the pole (£500).

23/50 Clerk's notes (need no approval)

- 1. Unclear signage regarding weight restrictions on Fishponds Bridge reported to NYCC 2.12.22.
- 2. Overgrown public footpath, Thorpe Underwood reported to NYC Paths w3w "alert.abandons.snored" CAMS 74056. Clerk to ascertain permitted width of public footpaths as some in the parish are hard to access.
- 3. Broken gate on public footpath w3w "booth.eventful.confetti" to be reported again with photos.
- 4. Overgrown footpath Main Street footpath to Kirby Hall reported to NYC (101010067412). This is on NYC seasonal vegetation cutting programme. LOPC approved to ask its grass contractor to trim the path when next in the village as it is almost impassable. Completed.
- 5. A request to NYC to clear the gullies along Main Street and Church Lane was made 4.9.23 Clerk to seek assurances from NYC that this was undertaken along with other gullies in the village.
- 6. Street lights no. 4 and 5 reported as not working 31.10.23. Repaired
- 7. Garden waste bins are no longer collected from the footpath outside Broomfield Cottages and need to be put on the roadside. This is a huge inconvenience, especially to the elderly and infirm villagers affected. The clerk has reported this to NYC and the County Councillor. The PC suggested that a relief team might have been unaware of the protocol and to check if further collections had gone ahead as before. If not, a resident can apply for assisted bin collections to NYC. Clerk to contact villager who raised the matter.
