3. IMPROVED WHITE LINING AT ENTRANCES TO VILLAGE.
4. IMPROVED & ENLARGED REPEATOR SIGNAGE THROUGH VILLAGE WITH REVIEW OF SPACING.

Wicken Bonhunt is a residential linear Village of just one road – the B1038 and circa 1 mile long.

Our Community Speedwatch Teams have accumulated evidence of an unacceptable number of vehicles exceeding the Speed Limit by excessive amounts.

We believe that the appraisal & outcomes of all our recent Speed Surveys have been slanted to favour Essex Highways agenda and not residents' needs

Excessive speeding is a danger and nuisance to all Wicken Bonhunt residents as well as horse riders, cyclists and pedestrians. Due as well to the narrowness of the provided footways and unnecessarily wide carriageway for a residential street.

Speeding needs to be effectively controlled so that all drivers adhere to the nationally provided speed limit.

We also have clear written evidence our campaign to reduce the nuisance of speeding drivers has now lasted 43 years.

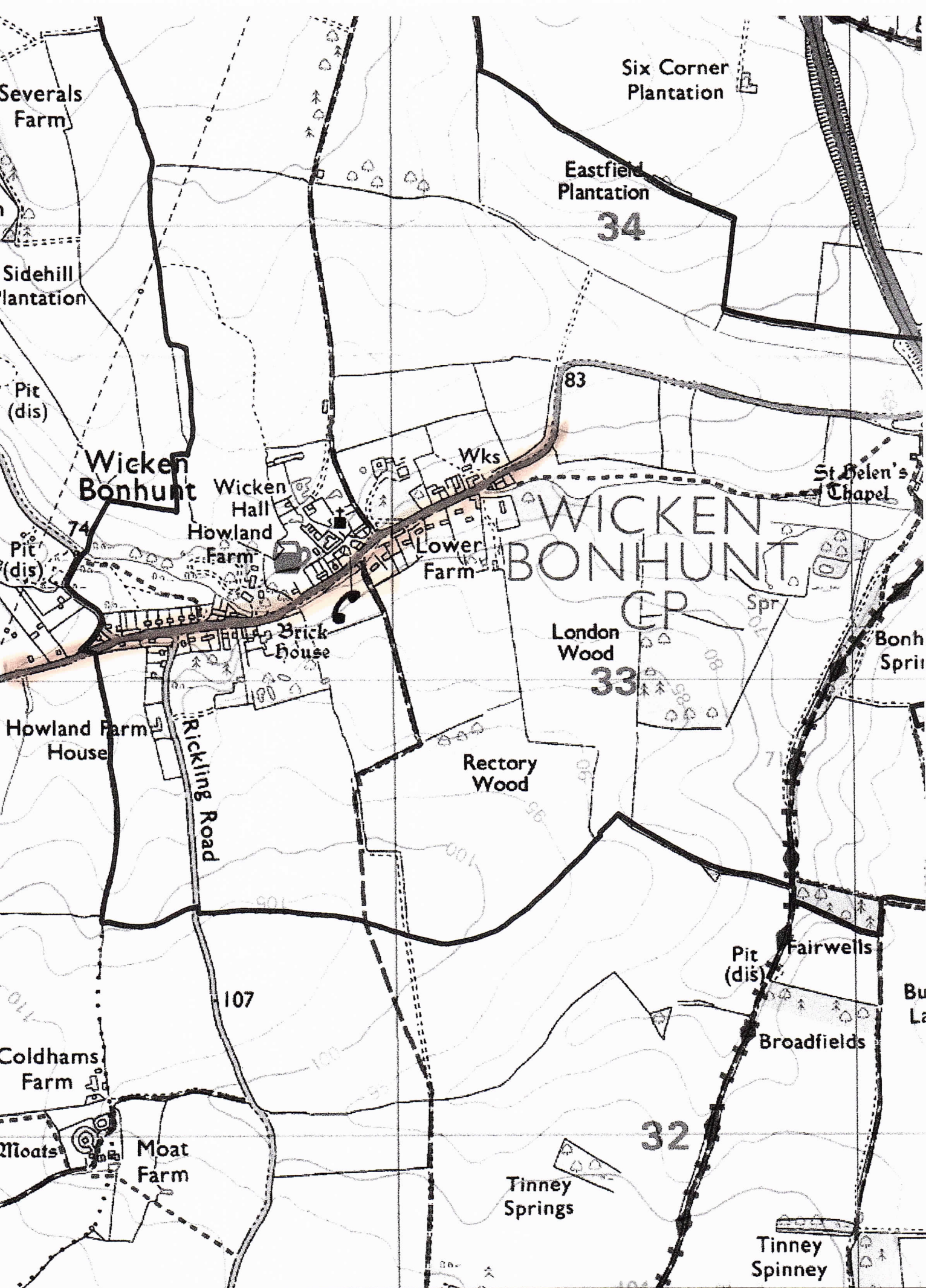
It is our opinion that County Council has a duty to ensure that all Wicken Bonhunt residents and users should be able to always rely upon enjoying this Village environment without the dangers, noise and nuisance of speeding traffic.

We call upon Essex County Council to implement at least all the measures in this application without any further delay.

We also call upon ECC to seriously consider providing our village with the following extra provisions to combat our speeding problem:

- Several strategically placed chicanes.
- An additional VAS sign at the Western village end
- Extra, "Smiley Speed Signs" as effective reminders.
- Reduction of the road width to discourage speeding drivers and, to consider providing safe area cycle paths
- Widening of footways to allow side by side pedestrians
- Solid white centre lines to discourage overtaking of vehicles that want to adhere to our speed limit.
